

Minutes of the Meeting of Stainforth Parish Council held in Stainforth Village Hall on Tuesday, 11 April 2017 at 7.30pm

Present: Cllrs Blackburn (Chairman, Sharp, Asher and Warren. Also the Clerk.

- 1 **Apologies** – County/Dist Cllr R C Welch and Sgt Les Moorhouse of the local police
- 2 **Casual Vacancy** – to consider co-option. An expression of interest was reported but it was not certain if the prospective candidate was eligible to stand at this time.
- 3 **Code of Conduct - Localism Act 2011**

Resolved: That the Minutes be approved as a true and correct record and signed by the Chairman.
- 5 **Matters Arising**
 - i) Packhorse bridge, Stainforth - additional repairs to be undertaken and monitored Members reported that the situation was not improving and the Clerk undertook to contact the owner's representatives again.

- 6 **Policing**
 - i) To receive the monthly report
March had been a quiet month for crime in general, with none at all being reported in Stainforth. Total Crime for all of Craven over the last 12 months is 1954 compared with 2020 last year, a reduction of 66. Craven Rural crime over the last 12 months was 1068 compared to 1098 in the previous year, a reduction of 30. However, there has been a sharp rise in retail thefts across the rural area and the police are keen to address this with retailers. As far as Stainforth is concerned, the police are also keen to see tight security around quad bikes and Land Rovers, as these remain a target. Crime in rural Craven remains low. There is still a full team of response staff at Settle, and Ingleton along with the Safer Neighbourhood PC's, and PCSO's.
In March, 2 speed camera vans and 6 staff arrived and are based at Skipton Police Station to cover Craven. The scheme will see them on the roads in Craven every day, some days 2 at once. It is hoped that with this, new locations will be covered. Any complaints regarding speeding should go through the reporting process on the Police Website:

C/64//35H Conversion of garage to form holiday accommodation (retrospective). Holly House, Holly Lane, Stainforth. **Permission granted.**

Cllr Asher had raised this item with particular reference to the voluntary collection of waste paper and card etc for the benefit of the local swimming pool. It was felt that a local reminder would be useful and the wording was discussed and agreed.
